# **57th Convention and Annual Meeting**

The NDTOA 2023 Convention will be held at the Ramada, 1400 Interchange Avenue, Bismarck ND, on December 4th and 5th. Speakers invited include Governor Burgum to lead-off the list, NDDOT Director Ron Henke to speak about the new Flexible Transportation Fund Program grants, Justin Messner and Brent Kahl will present on FEMA-NDDES applications and procedures, Alan Dybing will speak on the ND Road Safety Action Plan (grants for safety issues) and the new Road Needs Survey, and there are still more being lined up. Tuesday morning will be a choice of programs: Option A will feature zoning topics, zoning for animal agriculture, flood plain management, and general zoning issues. Option B will be Clerk training and the ATLR. Then back to one track with a question-and-answer period on grant funding with representatives from NDDOT, NDLTAP and UGPTI to answer all your questions about the transportation grant programs.

When the presentations and times are finalized, the agenda will be posted on our "new" website at NDTOA.COM.

On Monday afternoon the annual business meeting will see elections of the President, Vice President and three Directors. There will also be two By–Laws issues to vote on. The first is an annual membership fee change and the second is a title change for the Executive Secretary to Executive Director.

While the cost of everything is going up, the registration fee for this convention remains unchanged from last year, \$40 per officer attending if pre-registered by November 22. The charge at the door also remains the same as last year at \$60 per officer. ## PRESIDENT'S REPORT

Greetings Township Officers,

It certainly has been a busy summer for NDTOA. After the close of the legislative session in April, a few new laws required us to follow through with what lawmakers intended.

In June, NDTOA Executive Secretary Larry Syverson and myself were appointed to the Livestock Model Task Force. Several members of the newly appointed task force were able to take a bus tour to several livestock facilities in North Dakota. We also toured a dairy operation in Minnesota and the South Dakota State University dairy and hog facility. The object of our tour was to allow us to see and smell the confined animal feeding operations. It was amazing how clean and well-kept the facilities were and with very minimal odor. It also was discussed throughout the tour the positive reaction of neighbors around these facilities and the information about how the public was notified prior to the facilities being built. Several farmers around these facilities are seeing the benefits of the advanced manure handling systems that are now in place. They can be used by surrounding farmers to apply to their land to improve the soil and help with plant growth.

Another project that Larry and I have been working on is the Township Assistance Program. If you recall during the 2021 Legislative session, there was township funding that was approved in HB1015. Ten million dollars was appropriated for township road projects, however the ten million needed to be matched by federal dollars before any of the funds could be awarded to townships. Unfortunately, the federal match was never met and there were no funds available. When we went into the 2023 legislative session, legislators were asked if they could make the ten million dollars available for townships without having the federal match as a requirement. This language was added to HB 1012 and is now being worked on to get funding out to townships that applied. I hope that you were able to work with your counties to get your application in on time. The deadline to have the application submitted was October 6th.

There is also an additional program for road funding available through NDDOT for township projects. This funding can be applied for now and will come from the Flexible Funding that is available through NDDOT. To apply you must go to the NDDOT website and follow the instructions.

The last item that I need to remind all township officers of is your annual meeting, which will be held December 4th and 5th in Bismarck. I hope the weather cooperates with us and a large number of township officers are able to attend.

In recognition of his longstanding support of Grassroots Government, he was awarded the President's Award and declared to be an Honorary Township Officer.


Officer Elections to be held at this annual business meeting December 4 at 1 p.m.

### Township Officers' Association of North Dakota with Rail/Hwy Crossings

The North Dakota Department of Transportation (NDDOT) is requesting your assistance to identify locations within your jurisdiction where rail/highway crossing safety could be improved. The information provided should contain the location of the grade crossing by street or road name and the distance and direction to the nearest town(s). Please be specific about your concern or suggestion for improvement.

NDDOT has annual federal funds available for safety enhancement projects at rail/highway at-grade crossings. These funds are used for the installation of active warning devices (e.g. flashing light signals with gates), crossing signs and crossing surface improvements. The funding breakdown of a crossing project is 100% Federal funds until the end of the 2026 federal fiscal year.

Please remit your concerns or suggestions before December 29, 2023, so they can be included in the annual review process. Be assured past concerns have been incorporated in the statewide pool of prioritized crossings.

#### Grassroots Government Leadership Award

- Long-term or lasting benefit of the nominee's accomplishments.

## **Township Officers, Is It Time For A Dues Increase?**

If you recall, there was an article to increase dues in the last Grassroots. I would like to remind everyone of the proposed dues change that will be voted on at the NDTOA Annual Meeting held in Bismarck on December 4th and 5th.

A proposed dues increase of \$75 per township will be voted on. If the dues increase passes, it will bring the total dues paid to the state association to \$200 for organized townships. If the current number of townships continue to pay state dues, the increase would generate an additional \$100,500. Some may ask if a dues increase is necessary. You, the township officers need to decide. If we look back for the last 12 years, 2010 through 2021 our association had more than enough revenue to cover the expenses. In 2022 we had a loss of over \$9000, and even though we have not completed our year-end financials at this time it appears we will show a loss for 2023. We have revenue to cover these losses, however, you need to ask yourself how long we can deficit spend and still provide the necessary services that North Dakota Townships deserve.

## **Proposed By-Laws Changes**

There will be an election for two By-Laws changes held during the annual business meeting December 4 at 1:00 p.m. at the Ramada Inn of Bismarck, ND. Under the NDTOA Constitution each county is allowed two votes. Should there be more than two township officers from a county present for the election they must caucus to select the two voting delegates.

First Item: Article VIII of the By–Laws – Membership Fee of the Association

The 2022 annual meeting passed a resolution that seventyfive-dollar fee increase proposal shall be voted on by the 2023 annual meeting after the required notice has been published in the Grassroots Report at least thirty days prior to the meeting. Should this proposal be passed the annual membership fee of the Association would be two hundred dollars beginning in 2024. The revised Article VIII would read:

VIII.

The annual fee for membership in the association shall be <u>\$200.00</u> per year per township in counties with a county

organization and <u>\$205.00</u> per year per township in counties without a county organization. All dues shall be paid by May 1 and if unpaid shall become delinquent on October 1. A township shall be ineligible to vote at the Annual Meeting of the Association if dues are not paid by October 31 or may be allowed to vote at the discretion of the Association President.

Second Item: Article XI of the By–Laws – Appointment of the Executive Secretary

The Board of Directors has recommended that the title Executive Secretary be changed to Executive Director because the activities performed are more commonly attributed to an Executive Director in other associations. The revised Article XI would read:

XI.

At the first meeting of the Board of Directors after the annual meeting, the Board of Directors shall annually appoint an Executive <del>Secretary Director</del> who shall also serve as Secretary of the association and a Treasurer who shall serve as Treasurer of the association.



## THE COUNTRY LAWYER

Greetings! Wow—did that Summer ever go fast! Fall is a pleasant time of year—but full of sick 'Dad' jokes: Why do trees hate going to school in the fall? Because they get easily stumped; What do you get when you drop a pumpkin? Squash.; and What month does every tree dread? Sept-timberrrrrr!

Harvest is in full swing, and not much rain—yet—so haven't seen a lot of mud on our roads. Hopefully the operator will aid in cleaning the road surface when the mud does arrive. Mud could be deemed an 'obstruction' so the rules providing for removal of an obstruction can come in to play as well.

NDTOA is just a month or so away for the annual convention in Bismarck in the first part of December. See elsewhere in this issue for a short listing of the agenda items. There will also be a proposed change to our By-laws that will need approval by the convention, so it is important that we have a good turnout. I'm always surprised when visiting with township officers across the state that many have never been to a state meeting, or worse, thinking that they are not allowed to attend. The Convention is for all township officers, and is quite educational. And for me, it is always good to place a face with a name or a voice heard only on a phone call. Please make plans to attend! And remember, attending the convention is official business, so your township should pay for your registration fees, transportation and lodging while in Bismarck.

February workshops are also around the corner as well, so we'll finalize the locations and agenda at the December Bismarck meeting also. During the last years' sessions we experimented with one or two of the workshops being connected via 'zoom', so one could attend virtually without having to physically attend at one of the locations we visit. The Zoom meetings worked out quite well, so we will definitely do those again this time—so no excuses for not attending! These workshop sessions are another good way to get the word out, as we review the actions of the past legislative session, go over new handbook revisions, visit about how to resolve various township problems, plus we always end with a question and answer session with not only myself, but with all of the travelling team. And, I admit it can be discouraging to find out that many township officers fail to attend these workshops because once again they think that they are not allowed to attend, or "someone else from my township will go". And remember, both the state convention and the workshops are official township business, so expenses for attending can and should be reimbursable by the attendee's township, plus it should also qualify for daily pay. I think many township officers

forget that the residents of their township--plus absentee landowners as well for that matter--would rightfully expect that their supervisors and officers would avail themselves of every opportunity to learn about proper township procedures. Please mark your calendars for these upcoming events—I expect to see you there!

Try to get a road and sign survey accomplished yet this fall, before the snow flies. Check the reflectivity of signs after dark, and remember to document your trip for your records. Such a road survey trip is a' meeting' under our state open meeting rules, so make sure to post notice with the county auditor of your intended trip.

Here's hoping the rest of the harvest goes problem-free, and done safely as well. Hope to see you in Bismarck in December. Following are a few questions received in the office over the course of the Summer. TRM

**Q:** We've got some trees growing in the road right-of-way and the landowner is adamant that we leave them alone. It's making it difficult to traverse the road with large combine headers. Can we have a contractor remove the trees and pile them on the landowner's side?

A: Yes and No! The township has the right, and the obligation really, to remove these obstructions, and with proper notice to the landowner, the costs of removal can be charged against taxes. Piling the debris on the owner's property without permission, however, cannot be done. The stuff will have to be hauled away. This is why I sometimes suggest for the township to pay for the removal if the landowner will agree to piling the removed trees on his/her side, rather than the added expense of hauling—assuming of course that you have a cooperating landowner—which doesn't appear you have in this situation. Sure would have been a lot easier if the township officers years ago would have enforced the ditch-mowing procedures!

**Q:** We have a new business in our township and the owner naturally wants to put up an advertising sign. Do we have any control over the content and placement of the sign?

**A:** Obviously, the sign can't be within the 33 foot right-ofway as that would be an obstruction. Without being zoned with set-back requirements there's not much you can do beyond the 33 foot line. Probably the same with any content issues. Interestingly, there is a section of our law that deals with signs and billboards along State highways. See Section 24-17 of the Century Code. (not in our handbook, but available on-line on the State's website)

**Q:** I know the definition of "freeholder" means landowner. Does an oil company which is the owner of

## **Update On Grant Programs**

There were quite a few townships that applied for the Township Transportation Funding Program (TTFP) grants that originated after the 2021 legislative session. Unfortunately, that program required a federal discretionary grant before the state could fund a project, the federal grants never materialized and the state fund of ten million dollars went unused. Those funds were rolled over into the new biennium after the 2023 session and became the Township Assistance Program (TAP). The applications from the TTFP program did not carry over to the TAP program, projects needed to be resubmitted to the new program and the application period for that ended on October 6th. There were sixty-eight million dollars' worth of applications for the ten million that is available. The applications that don't meet the requirements are being weeded out and the qualifying applications will be judged for value to the area transportation network. The TAP program will end when the ten million is spent.

The new grant program termed the Flexible Transportation Fund Program (FTFP) has begun. This is a continuing program that will offer grant opportunities periodically; the application period for the first round started in early October and will end on December 31, 2023. Like the TAP grants, the applications for FTFP must be done through the county. The applications for the TAP did not directly carry over into the FTFP as there are some different requirements for the two different programs. But if a township has the information available for the earlier programs it should not be too difficult to complete the new program application. NDDOT will contact applicants to supply additional information.

Projects must meet the requirements, they must be on a local transportation corridor, that is a road that connects from one county major connector (CMC), state highway, or BIA highway to another. A qualifying road can also connect from a major economic generator to a county or other major roadway. If there is more than one project they can be added together, but all projects must meet the requirements. An application to gravel all the roads in the township will not qualify nor will graveling a mile here and there. A gravel project will be a layer three inches thick when packed across the surface of the road, it should also include road preparation work and culvert replacement if necessary.

Townships must levy 18 mills to qualify for FTFP grants, the deadline for increasing the levy for 2024 passed on October 10th, 2023. Any changes after that will not be effective until 2025.

Funding will be a reimbursement process through the county just like it is for other state to county project costs. The townships will not be receiving and handling any funds from the grants.

There will be more information available at the annual convention on December 4th and 5th. There will be a question-and-answer session with representatives of NDDOT and Upper Great Plains Transportation Institute so you can get your answers.

the mineral rights below the surface also a freeholder? We had an oil guy claim he could vote at a township meeting because he too, was a freeholder.

**A:** First of all, being a freeholder is not a requirement for voting—one must be a resident to be a township voter—obviously the oil person is not a resident. And, a "freeholder" is defined as in our state as ".....means the legal title owner of the surface estate in real property." (Section 58–01–01.1 N.D.C.C.) On a side note, freeholders do have a few rights under township laws. I can think of a couple of examples: they can vote in special assessment district elections; and also can petition the township clerk to force the calling of a meeting if the supervisors fail to do so.

**Q:** We have a township road that goes around a slough it's on a section line except where it veers off to go around the slough. We got permission and an easement from the landowner to widen and improve the road where it goes on his property, but he's saying we don't have the authority to build it up to the extent that we want. It is a fairly busy road and we want to make it safe.

**A:** Township supervisors have the general supervision over the roads, highways, and bridges throughout the township......" Section 24-06-01 N.D.C.C. And, the township road overseer shall: "..... Have direct charge of the construction and maintenance of all township highways......" Section 58-12-03(1). I believe these two sections of State law are quite clear about your authority. Making township roadways safe for the travelling public will win out every time. And, I'm glad you got an easement for the property make sure you get it filed at the County Recorder's office, so a potential future owner of the land is put on notice of the easement.

#### ELIGIBILITY

The award will be presented to an individual, locally elected official, currently in office. It will recognize him or her for their outstanding contributions on a sustained basis or from a single performance.

Nominees should have responsibility for accomplishing or causing to be accomplished significant programs or projects within their area of responsibility, to the ultimate benefit of the general public.

Examples of such professional accomplishments include local government cost-cutting, coordination of a major local volunteer effort, and promoting townships at the national level, establishing new local services or programs, and success in securing public or private funding for local projects.

#### **SELECTING CRITERIA**

Nomination should include as much information as possible, such as:

- Complexity of the problem(s) addressed.
- Measurable improvements resulting from nominee's accomplishments.
- Use of original, innovative or creative approaches and solutions in difficult situations.
- Long-term or lasting benefit of the nominee's accomplishments.


