Township bill heads to Gov's desk!

SB 2178 which gives townships authority to increase their special road fund to \$500,000 was passed by the full House on March 6 during Township Day! The bill received an 87-0 vote and now heads to Governor Burgum's desk for signature.

Township Day 2023 held at the Capitol

The first ever **Township Day was held on Monday, March 6** and some township officers from around the State an in depth look at the legislative process first-hand. About a dozen township officers braved the winter storm to be in Bismarck for the day. Officers attended various hearings including SB 2183, the snow removal grant bill in the House Appropriations Committee. Along with Larry Syverson from NDTOA, Joe Mathern, township officer from Ransom County provided testimony to support the bill.

Following lunch, several attendees sat on the House floor with their Representatives for the floor session. Township Day was recognized by the Speaker of the House, Dennis Johnson. **During the House floor session, Senate Bill 2178 was passed unanimously, and sent to Governor Burgum's desk**.
