NDTOA Bills Clear First Hurdles

Two bills introduced at the request of NDTOA have passed the first steps to becoming law. **Senate Bill 2178**, which raises the township special road fund limit from \$100K to \$500K passed the Senate Finance & Taxation Committee 6-0, and the full Senate by a vote of 47-0. The bill must also pass the full House after the crossover.

House Bill 1236, which raises the allowable daily pay rate for township officers to \$100 and the annual limit to \$4,000 passed the House Political Subdivisions Committee by a vote of 13-0. The bill also allows townships to meet any day in March. The full House will vote on the bill early next week.

HB 1147 establishes a distinct "bridge fund" to address the county and township bridge needs. NDTOA stood up in support of the bill, sponsored by Rep. Paul Thomas.

HB 1148 establishes an "agriculture infrastructure fund" to assist political subdivisions with ag-related road needs when a new major facility is proposed, such as a soybean crushing plant. ND Farmers Union has asked for NDTOA Support.

SB 2183 is a \$30 million appropriation for emergency snow removal grants to political subdivisions. This bill attempts to help political subs that have already exceeded their snow removal budgets. **The public hearing will be Jan 25 @ 10:30am**.

SB 2275 is aimed at prioritizing the municipal infrastructure "Prairie Dog" bucket, which is filled with oil and gas revenues in the funding stream. **The public hearing will be Jan 24 @ 9:00 am.**

SB 2329 requires a portion of the Motor Vehicle Excise Tax revenue be designated for township road funding. There are many legislators working on exactly how to do this, so it is a fluid situation at the moment. **The public hearing will be Jan 24 @ 9:30 am.**
