# Secretary's Corner

I have a sign on my desk which says... "Well, what have you done today for the NDTOA?"

Today I would like to report to you that your office in Brocket has had many calls from the membership and I wish to thank each and every one of you. The high speed Internet connection that the state board insisted on gives me the ability to check the ND Century Code and the most current attorney general opinions on questions raised by our calling members.

May 1st was the first day I began full time work as your Executive Secretary/ Director of Governmental Relations. I am trying to keep a constant vigil on happenings in our state that have and are going to affect township government.

The Finance and Taxation Committee actions warrant our attendance. They have many proposals before them; one being to put property taxes on farm homes. A proposal to reduce property taxes may cost us in other areas and the State Board has representatives at each meeting to monitor the proposals.

The opportunity to work for the NDTOA on a full time basis has allowed me to review some of our past organiza-

tional actions. Even though the NDTOA is a tax exempt organization, the treasurer has been paying sales tax on many purchases that he shouldn't have. I contacted ND Tax Commissioner Cory Fong, and he has arranged to allow us to go back three years to try to get refunds for the overpayment of those taxes if we can get access to the records of payments made.

As your representative on the ACIR, I have surfaced the need for a raise in the 18 mill cap to 30 mills but deferred testimony until after some of the tax committee proposals have surfaced. I have asked for help from the membership in presenting testimony before the committee at our next meeting on July 18th.

Establishing the Brocket office took quite a bit of time. The new fax, copier and printer is a good addition to the NDTOA office equipment. A separate phone line for NDTOA at 701-655-3513 is great. The e-mail with DSL connections at ndtoa@polarcomm.com has been working well. The new phone has many new services which help me communicate with our membership better than I have been able to in the past.

State Board action directed Ken to get a cell phone for NDTOA use when he is away from the office and that number is 701-



230-4118. We now have a new tape recorder to record the State Board minutes and is a big help to get the minutes accurately written.

On June 10th, the State Board met in Brocket and inspected their newly established office. We had a cookout at Ken and Darleen's house which consisted of a lunch and an evening fish fry on the grill done by Chuck and Joan Thacker, backed up by pork chops on the grill done by Ken and Darleen.





# North Dakota Public Finance Authority

The North Dakota Public Finance Authority (PFA) is an agency of the State of North Dakota that issues bonds to make funds available for loans to political subdivisions, including counties and townships.

The PFA does this by issuing bonds and using the proceeds to purchase municipal securities issued by the borrowing political subdivisions. (The term "municipal security" refers to any debt obligation issued by a state or a political subdivision in connection with the borrowing of money.)

Generally, a loan can be made by the PFA for any purpose for which a political subdivision has the legal authority to borrow money through the issuance of its municipal securities.

#### **Capital Financing Program (CFP):**

Under its Capital Financing Program (CFP), the PFA sells its bonds in the open market through a competitive bid process. The interest rates that the PFA pays on its CFP bonds at the time of issuance are passed through to the political subdivision when the PFA enters into a loan agreement with the borrowing political subdivision.

The CFP has been assigned an "A" rating by Standard & Poor's, which allows the PFA to provide loans to political subdivisions of North Dakota at attractive interest rates. In some cases, generally for short-term loans (less than 5 years) of less than \$100,000, the PFA may make loans without issuing bonds to obtain the loan funds.

The application and review process is similar to that under the CFP, however there is no underwriter's discount charged to the borrower. There may be only minimal administrative fees for these direct loans and interest rates are set by agreement between the PFA and the borrower.

# **CFP Loan Application and Review Process:**

Upon receipt of a loan application, the PFA prepares an amortization

schedule showing projected interest rates and the dates and amounts of principal and interest payments, as well as the projected costs, including the underwriter's discount, administrative fees, bond counsel and financial advisor fees, and reserve letter of credit fees.

This schedule is provided to the political subdivision with the understanding that the actual interest rates are not set until the PFA bonds are sold.

Each loan application is subject to an initial review by the PFA. For loans that exceed \$200,000, the application is then submitted to PFA's Financial Advisor, Public Financial Management, to prepare a market analysis.

Following this review and analysis, the information is submitted to PFA's Advisory Committee, which makes a recommendation to the Industrial Commission to either approve or disapprove the loan. The loan is then presented to the Industrial Commission for final approval. For loan amounts less than \$200,000, PFA's Advisory Committee can provide final approval.

#### **Bond Counsel:**

A political subdivision receiving a loan from the PFA must retain the services of recognized bond counsel. The costs associated with this service are the responsibility of the political subdivision. Bond counsel should be retained as soon as the political subdivision considers the option of borrowing money.

Bond counsel will generally be familiar with the requirements a political subdivision must comply with to issue municipal securities and it is important that all applicable state statutory requirements and federal tax law requirements be met in order for the securities to qualify as tax-exempt obligations.

# The Country Lawyer

Can a "Quarter line" road be a township road?

A. Yes, if there is an easement given for it. Roads oftentimes were put on the half-mile line because the section line wasn't available because of water or topography. If you're lucky maybe something is written in either old clerk's minutes or filed at the Courthouse. Most of these roads, however, were put in with a "handshake" easement, and everyone involved is long gone. There is a process to have a road declared a "public road by prescription," but that takes a Judge at a Court hearing to do that.

Q. Does a township road have to be graveled?

A. No. Whether to gravel or not is a function of the residents of the township at the annual meeting determining where they want to spend their money, and directing the supervisors to do so.

# State Bonding Fund — Legislative Update

For those North Dakota Townships who did not receive or who have not acted on the State Bonding Fund's June 2005 Legislative changes notification, we provide you with this summary that describes the substantive changes to NDCC 26.1-21 (State Bonding Fund):

**1. Section 26.1-21-10** Automatic Insurance of state and political subdivisions.

Each State agency and each political subdivision (this includes townships) must apply to the Fund to be bonded. The application must be filed biennially or when a change in coverage is requested.

The Fund is using a calendar year for the bonding period, meaning January 1, 2006 is the effective date for all bonds. Bonds older than January 1, 2006 have expired. If you have not completed an application for coverage, form (SFN 54369), it is not too late.

The following are commonly asked questions when completing the Application for Coverage:

- Who is covered by the Bond? All employees, including the board of supervisor, whether paid or not.
- What kind of coverage does the Bond provide? The bond protects the entity (township) against theft of its money or property by an employee.
- Section 3 Audits. Townships are not audited by an independent CPA or Office of the State Auditor. However, a Township is required to conduct its own audit. You need to explain how your books are audited in the appropriate section under

"Audits" where it states "If an independent CPA or the State Auditor is not retained, who is responsible for auditing the books?"

- Section 5 Bank Account Control. All questions in this section need to be answered. We understand if a "weakness" cannot be corrected. However, we strongly discourage the practice of pre-signing checks for the purpose of a countersignature, the use of signing machines or signatures plates, and recommend a countersignature on all checks.
- Section 6 Computer Control. Townships can just indicate "not applicable" in this section.
- Section 7 Money Security and Payroll Exposures. Under "Checks" enter all revenue, whether it be a direct deposit or automatic transfer, the township received over the previous 12 months. Under "Negotiable Securities" enter any funds you have set aside in a savings account, CD or money market account for road work/repairs, building repairs, emergencies.
- Section 8 Coverage Requested. Enter 25% of the total of Section 7 in "Limits Requested."

All questions must be answered and must be signed and dated by an official duly authorized to sign such documents.

**2. Section 26.1-21-15** Limitation of time for bringing action against the fund – Interest – Limitation on time for fund liability.

Interest on a claim will not run until the claim is filed with the commissioner and the liability of the Fund is limited to a breach of a condition of the bond which occurs within two years before the date of filing the claim with the commissioner. Loren Ingebretsen, President of the Minnesota Township Officers Association, has again accepted our invitation to attend the NDTOA 2006 annual meeting.


