The convention committee is working hard to put together an informative agenda for this meeting and I urge everyone to attend to see what we have been up to for the past twelve months and give us direction for the next twelve months and more. NDTOA is your organization.

In July seven members of your Board of Directors attended the multi-state conference held in New Ulm, MN. A detailed report on this meeting is also found elsewhere in this issue.

One interesting item I noted is that Minnesota townships pay an average of \$450/township for dues to the state association (rate depends on population) and there are only two townships that are not dues paying members.

We also had a good conversation with Jennifer Immo of the Ferguson Group (yes, the same organization we were disgruntled with a few years ago when we decided to discontinue our membership in NATaT). It appears there has been a major change in the staff and their attitude


I have seen much information over the past few months that indicate the Ferguson Group is doing a much better job of making aware of the needs of the rural communities to the U.S. legislative bodies than they were doing a few years

At the very least, we offered to help where we could on issues relating to rural problems.

Our Directors of Intergovernmental Relations (Ken and Larry) continue to closely watch actions and attend meetings of legislative interim committees, Governor's Task Force on Property Tax Reform, transportation coalition, ACIR, etc., etc.

I have no doubt that we are far better

off as a result of the efforts and presence of Ken and Larry at the various meetings and hearings they attend. They are of-



ten called upon to give information or recommendations on the subject at hand.

I would like to remind everyone to check out our website - www.ndtoa.com which has many items that may be of interest to you. The discussion forum has many questions and answers that may be of much help and more questions are being posted often, so be sure to check it out frequently.

We are continually pursuing more participation of the townships in the state to support NDTOA by paying dues to our organization. This effort includes requesting counties that have unorganized townships to pay dues for the unorganized townships in their county. Any benefits such as transportation funding (formerly one cent gas tax) begun in the early 1980s and the special distributions of the past few years were obtained through much effort by NDTOA and are received by every township in the state whether they are organized unorganized and whether they are members of NDTOA or not.

This means we need the help of as many as possible to "help pull the load". If you are a township supervisor in an organized township or a county commissioner in a county that has unorganized townships, we would ask you to ensure each township is doing what it can to support our efforts.

We currently have the counties of Bottineau, Bowman and Burleigh paying NDTOA dues for their unorganized townships and are hoping more county commissions have similar foresight and step up to support our efforts.

Remember, the road going by your place could be the one that doesn't get maintained as good as you would like because of lack of funds.

By-Laws and Constitution Changes Recommended



The NDTOA Board of Directors approved the following changes on October 4, 2014:

Constitution: Article IV–second sentence; replace "township officers present at the annual meeting" with "membership of the association during annual meetings held in odd numbered years."

By-Laws: Article VI—first sentence; replace "at large" with ", each representing a separate district, but elected by the entire association". Second sentence—delete entire sentence and replace with "Directors must be elected township officers and a member of the association as defined in Article III of the Constitution". Last sentence—delete "at-large".

Greetings! Fall is here, and I don't know where the Summer went. Seems like I was just planting tomatoes in the garden, looking forward to that very first ripe one, and now, all of sudden the plants have already succumbed to the first frost.

At least baseball is still happening—although it too can be a brutal sport—I mean, suppose your errors were counted and published in the paper every day!

Our State NDTOA convention is soon upon us, so I hope many of you are planning on attending. The schedule of events is still in the works but I see that I will be on the program again with a question & answer period and open forum.

I really enjoy this, as I get to put a face with a name finally after talking with many of you over the phone.

Please seriously consider attending this year, as we really need more township officers to participate. It's a valid expense for your township, so your treasurer should reimburse you for expenses for attending.

There also some proposed constitutional and by-law changes which are listed elsewhere which require your consideration and vote as well

The November elections are also fast approaching, and I hope that township officers will make sure to attend the various candidate forums and debates that are held in the legislative districts.

This is a good time to introduce yourselves to those who will represent us at the next session starting in January in Bismarck. This is especially important for those who live in urban districts, where sometimes just a portion of a township may also be part of the overall "city" district. A lot of those urban legislators don't realize they need to be cognizant of rural and township issues, too, because they also have constituents who live out in the coun-

Remember to do a road and sign survey yet this Fall. You can use the forms that the Insurance Reserve Fund provides, or just use a regular notebook

The important thing is to document your trip and note those signs that should be replaced, and note those roads that need some work.

I think it is especially important for officers living on the north side of the township to check the roads on the south side for example. And, vice versa.

Asking one of the county water board members to ride along is also a good idea if you have some perennial washout areas that always need attention. (And, if you don't get along with your water board—get that situation fixed as well—we're all in this together!)

Fall is also 'field scraper' time, so be especially vigilant for those operators that insist on cleaning road ditches without permission. You probably know in advance who the usual offenders are, so be pro-active and notify them even before they start fall's work that they need to get prior township approval before doing any work.

Here's hoping everyone has a safe Fall season. Following are a few questions I've received in the office. TRM

Question: One of our boundary roads with the adjacent township should probably labelled for minimum maintenance, but the



other township doesn't want to help pay for the signs. We normally share the cost of gravelling, etc. What should we do?

Answer: If you share the expenses for maintenance, then my guess is that the signage expense should be shared also. You may want to check which township lists the road on the rolls for state funding for roads -the former gas tax list.

The thing about a minimum maintenance designation (assuming it meets all the requirements) is that you probably won't have to provide snow removal because no one lives on the road. Ouite a savings as long as the road is signed properly.

Question: We have a subdivision in our township, and the residents there always complain about the snow removal, or lack of it. What is our responsibility?

Answer: I'm assuming that the subdivision roads are township roads-although in many subdivisions that may be a wrong assumption—it all depends on agreements (if any) that the township made with the original developer.

You can only spend monies that you have, so it may be time to have an informational meeting with the subdivision residents.

Ask your county auditor to provide you with the amount of taxes paid by a typical house in the subdivision. The auditor may even be able to provide a listing of all the properties in the subdivision and the corresponding amount of tax paid.

Then, look at the amount of the total tax paid that is credited to the township—it's usually a paltry amount compared to what the county and school gets.

Maybe on a \$1,500 tax bill the township only gets 60 bucks, as an example. That usually gets the residents' attention, in that all of their taxes don't all go to pay for the snowplow!

Question: Our water board is not very helpful when it comes to us making culvert decisions in our roads. They always say it's not their responsibility.

Answer: They are sort of correct. Culvert decisions under roads are indeed the road authority's sole jurisdiction.

However, I always say it's the township's road, but it's the water board's water. The century code requires notification to a county water board by a township of a culvert installation so the water board can "submit comments". See page 84 of our handbook, Sec. 24-06 -34.

Those comments are not whether a culvert can be installed or not, but helpful comments regarding sizing, location, etc. which the township would not necessarily have to follow.

By working together, the township and water board may be able to avert more water problems downstreamwhich problems are definitely under the water board's jurisdiction.

Question: The railroad wants us to take out a crossing over their line. It's on a section line, but it is just a prairie trail. Do we have to take it out?


Answer: The magic words you stated is that it is a section line. As long as the township wants to keep the section line open, then the railroad has no choice. However, if you do decide to close the road because of its low use, I would suggest a written agreement with the railroad that they will agree to re-open the crossing if needed by the township in the future.

Intermin Committees Wrap it Up By Larry Syverson, Past President

As Election Day nears and not too far behind that the beginning of the 64th Assembly of the North Dakota Legislature looms, the interim committees are concluding their work.

At the final meeting of the ACIR the commission studied the audit process of political subdivisions, the need to create a uniform chart of accounts, and the use of the state website.

The commission also reviewed efforts to establish uniform property tax statements among counties. The goal here is to make all county tax statements as similar as possible given that they are each a product of various software vendors.

At my request there was a presentation by Mr. Myles Vosberg, Director, Tax Administration Division, Tax Department, regarding application of city sales taxes for products and services delivered outside the city.

Applicable sales taxes are determined at the point of delivery, if they are delivered outside of the city the city tax does not apply. He told

us that the system uses the 9 digit zip code along with GIS services to assign the proper sales taxes to be imposed upon an address. Stating that errors might occur in areas bordering cities if they are not properly mapped.

Following Mr. Vosberg's presentation I passed out a list of rural addresses (township officers) and told the commission that most of those rural addresses, from one area of the state, came back as city taxable even though they were miles outside of any city limits.

Mr. Vosberg said the Department had been unaware of this error and they will look into it. I will go into this further in another article.

Interim committees do not pass bills but rather they recommend bill drafts be considered by the Legislative Management Committee for introduction to the next session of the legislature. These were the recommendations the ACIR forwarded at the last meeting:

A bill draft for a study resolution relating to reports from political subdivisions required by law. How many of the required reports serve the purpose for which they were intended, (if any)?

A study resolution relating to statutory references to political subdivisions. The definition of political subdivisions seems to change in the various areas of the state statutes. The study would look into making this more consistent.

A bill draft to allow a township to reclaim zoning authority previously surrendered to the county. This would apply to cases where the township gave its zoning authority to the county without enacting a joint powers agreement. It will require the consent of the county board. This bill would make the authority recoverable just as if it had been transferred in a joint powers agreement, the method which has been required since the Constitution was revised in 1981.

At its final meeting of the interim the Taxation Committee recommended a bill draft limiting the use of modifiers in agricultural property assessments.


NDTOA Director Positions Open for Election

Township Road Mileage Certifications Require New Data

The North Dakota Legislature has been increasing its use of one-time funding distributions to townships.

For my office to accurately distribute these funds, the biennial road mileage certification forms that are completed and certified by each county had significant changes over previous versions.

The changes included reporting the specific road miles for both organized and unorganized townships, and required individual township range numbers for the unorganized townships.

More information was also needed

for townships that are located in more than one county, or if different parts of the congressional township are under separate organization.

An example of this would be when part of a congressional township is organized, while the other part remains unorganized.

Sliver townships, along with their township range numbers, also needed to be reported. A sliver township runs along the border of Canada, Minnesota, Montana and South Dakota and may be organized with an adjoining township but have a different congressional township and range number.

My office has received questions about the definition of a "congressional township." It is defined as "each specific township and range number, regardless of organization."

It was important that we capture all congressional townships in the event that the Legislature decides to allocate money on a per-township basis.

Thank you for your cooperation in submitting accurate information about your township road mileage. It helps us to distribute state funds in the most accurate way possible.

Grassroots Government Leadership Award

To recognize the leadership, creativity, and dedication of township officials, the NDTOA has established a leadership award to pay tribute every year to an individual whose community service exhibits the highest standard of dedication, ability and service.

ELIGIBILITY

The award will be presented to an individual, locally elected official, currently in office. It will recognize him or her for their outstanding contributions on a sustained basis or from a single performance.

Nominees should have responsibility for accomplishing or causing to be accomplished significant programs or projects within their area of responsibility, to the ultimate benefit of the general public.

Examples of such professional accomplishments include local government cost-cutting, coordination of a major local volunteer effort, and promoting townships at the national level, establishing new local services or programs, and success in securing public or private funding for local projects.

SELECTING CRITERIA

Nomination should include specific reference to the following features of the nominee's accomplishments as applicable:

- Complexity of the problem(s) addressed.
- Measurable improvements resulting from nominee's accomplishments.

- ❖ Use of original, innovative or creative approaches and solutions in difficult situations.
- ❖ Long-term or lasting benefit of the nominee's accomplishments.

Are You Paying Too Many Taxes? Submitted by Larry Syverson

Most everyone feels they are, but in some cases the taxes inflicted are not even legal. As a rural township resident I am used to paying for all the services we get with property tax.

I am a bit irritated when I visit a "city" and I have to pay someone else's property taxes, called "local option city sales tax". What really set me off was a bill from a new internet service provider that included 7% ND sales tax for service at my farm home.

I contacted that ISP and told them of their error, the applicable ND tax is 5%. They replied with a link to the ND Tax website, "Local Tax Rate Locator" and explained that is how they have to apply the tax.

I used the locator, entering my 9 digit zip code 58257-9011 and there it was: ND sales 5%; Traill County 0%: Mayville City 2%.

I called the Tax Commissioner's office and told them of their error, I was told that it would get checked out and corrected but that the website data is updated quarterly so it would be December before it would show up.

During that conversation it occurred to me that if this happened to me it most likely was happening to others. I started checking, first my own township board; every one came back with the Portland 2% as most of the township is served by the Portland post office.

I brought out the NDTOA mailing list and continued checking, I found that every rural Mayville address is being charged the city tax, the same is true for Portland, Hillsboro, Hatton, Finley, and Hope.

What I found was that in Traill and Steele Counties if you get your mail from a town with a local option tax you are being charged that tax on any goods and services delivered to your rural address. One Steele county commissioner is being charged the Portland 2% but not the Steele county 1%, some Traill county townships are being charged the Cass county .5%.

I checked a few other addresses in other areas of the state where there is a city sales tax but did not find the error anywhere else. These checks were limited and incomplete. The error may be occurring in other areas but my sampling did not pick them up.

I again called the tax department and informed them that the error involved much more than my address. In fact most of the rural residents in at least two counties are being inappropriately charged these city taxes. I was told the compliance supervisor would be informed of the problem.

I gave them my email address and phone number and asked to be informed of any developments.

I found it very interesting that as of a month later, at the meeting of the ACIR, the Director of Tax Administration had not yet been informed that the department was a party to an illegal tax imposition of this scale.

It seems the tax department is getting bad data from some contractor. I hope to find out who that contractor is that is getting paid for doing a lousy job and causing rural citizens to pay unfounded taxes.

I told the tax department if they find out who provided the data for that list of cities they should suspect any other work that came from that same source, which could lead them to errors in other parts of the state.

Does this error affect you? I don't know and the only way to know for

sure is to test your address on the Tax Department site Local Tax Rate Locator:

https://apps.nd.gov/tax/tap/_/#1.

You will need the 9 digit zip code, if you don't have the +4 digits there is a tool on that page for determining that from your address.

If you get your mail in a PO Box the city tax will show to apply, be sure to use your 911 or physical address for this test.

If you find an error for your address please let me know so I can add you to the list and we can further check your area for more problems.

What kinds of things get taxed by this? As I mentioned, Internet service, also cell phone service, Internet purchases, telephone orders, mail orders and anything which you take possession of outside of city limits

If you get something in town the city tax applies, if it is delivered to you out of city limits it does not but you could get charged anyway because of this error.

Many questions remain. Who is responsible? How long has this been going on? How many areas of the state are affected? How does one get his money back?

Will the state be as much help to us getting our money back as it was in collecting the mistaken tax for the cities?

Will the Tax Department take a more active role in ensuring the accuracy of their system? How about putting a big red button on their website for testing the tax rates?

It would require that a single schedule of modifiers would be adopted by the State Supervisor of Assessments and use of modifiers within counties statewide would be restricted to the modifiers provided in that schedule.

This bill came about because many of the issues being addressed through the application of modifiers have already been accounted for in the soil survey.

It was said that if a modifier is applied, the property is essentially receiving a double modification. Some other tax committee bill draft recommendations included:

- □ Extending the state-paid 12 percent property tax relief credit enacted in 2013.
- □ The replacement of mill rates with property tax determination based on cents per thousand dollars of taxable valuation. (Replace a 4 letter word with a half sentence definition of that word).
- ☐ To provide that property tax levies requested by unelected boards (appointed boards) are subject to adjustment by the board of county commissioners or city governing body.

- ☐ That rural fire department excess levy increase must get approval by mail ballot election.
- □ Requiring property assessor certification. (180 hour training)

The Economic Impact Committee held its last meeting on September 29th. There was a presentation by Mr. Grant Levi, Director of Department of Transportation, regarding federal transportation funding, transportation project status, department initiatives, and the short line railroad program.

He reported that the funding that came out of the 2013 session has been put to good use by ND DOT, cities, counties and townships.

The final meeting of the Energy Development and Transmission Committee will be held on October 16 in Grand Forks. There is one bill draft they are considering which will definitely bear watching, it concerns crude oil and natural gas exploration landfills. This bill could eliminate local control of permitting those landfills.

The last meeting of the Governor's Task Force on Property Tax is coming up on October 29, at which time it will be interesting to see the

revised section dealing with township levies.

That was just a quick run-down of some of the committee action the last couple of months and what is coming in the next week or two. We will continue to monitor all the activities and be there to ensure the best results we can get.

♦ Several townships are only using one signature on their checks. NDCC requires signatures of Board Chairman, Clerk, and Treasurer.

The state bonding fund requires at least two signatures or you could not be covered if there were a loss.
