

# NDTOA 47th ANNUAL MEETING PLANNED

The 47th Annual Meeting of the NDTOA will be held at the Grand Hotel located at 1505 North Broadway Minot, ND beginning with registration on December 2 at 8:00 a.m.

All township officers are invited to attend including supervisors, clerks, treasurers, assessors and any other appointed or elected officers of your township.

President Larry Syverson will open the meeting and serve as the Master of Ceremonies until the conclusion at noon on Tuesday, December 3rd.

A special block of rooms has been set aside for ND Township officers if you make your room reservations by November 15<sup>th</sup>. Be sure you mention that you are a ND township officer.

This year's registration fee has been set the same as last year: \$40 for pre-registration and \$50 at the door. The fee includes a noon lunch, an evening banquet and morning and afternoon coffee and cookies supplied by the NDIRF.

The Monday morning session will feature ND Tax Commissioner, Cory Fong, who will speak on the new property tax records required by township assessors.

Steve Spilde, CEO of the ND Insurance Reserve Fund will report on the activities of the NDIRF throughout this last year's business.

The Ward County Sheriff's Department will discuss what the new oil boom has created for them.


Tom Moe, association legal counsel—thanks for the frequent advice.

# The Country Lawyer by Thomas R. Moe, Attorney-at-Law

Greetings! It's almost November and the year end is approaching. Can it be that the white stuff will be here soon? The government "shut-down" has come and gone, and I'm not so sure that anything was truly accomplished.

It seems that everything now is under federal government control, except the national debt and the budget. The federal government could take a good lesson from North Dakota townships!

With the onset of winter and end of the harvest, township officers probably will still have time to get a road and sign survey in before it's too late.

One advantage of the lateness of the year for doing the survey is that it should be easier to check for sign reflectively at night time, given the fact that we get nightfall sooner. Make sure you document your survey visit and make plans for changes, especially with signs.

The state convention is soon upon us as well, and I'm hoping that many of you will make the trip to Minot. There's a great program in the offing, with good speakers and information presented.

I enjoy meeting and visiting with the attendees, as it gives me an opportunity to put a name with a face. And, we always have a good question and answer session at the meeting. Attending the convention is valid township business and the expenses for coming to Minot should be paid for by your township.

Another opportunity to meet and greet is that our biennial workshop sessions are again being scheduled for next February, 2014.

Please make plans now to attend one of these workshops when we are in your area. Township officers attending can also have their townships provide for their expenses. Most workshops are close enough so that one can attend and travel home the same day.

These workshops are wonderful opportunities for questions and answer sessions, and going over new legislation and the new version of the handbook.

Here's hoping you have a safe holiday season. I hope to see you down the road at Minot in December and at one of the workshops next February! Following are some of the questions I've received at my office from township officers. TRM

Q. What is exactly the relationship between a township and a water board? We always have problems with figuring out who has authority over a culvert.

A. Remember this simple rule: It's the township's road and the water board's water. Always ask this question of yourself when contemplating a culvert replacement—Who wants the culvert? If it's the adjacent land-owner, then the water board will have jurisdiction because it will be a drainage project. The township will have to be notified and involved with the ultimate decision, because the road and road ditch will be involved with the landowner's drainage project.

If however, the township is needing the culvert because the road is being inundated, then the township has the jurisdiction. The water board is supposed to be notified for its recommendation about sizing, etc., but cannot override the township's decision to protect its road.

Cooperation between the two entities is critical, and both townships and county water boards should not treat each other as adversaries, but rather has two integrated partners in

the safe and orderly water movement within the township.

**Q. Can townships make charitable donations?** How about donations to road projects in an adjacent township? Their improved road "next door" will greatly help some of our residents in getting out in times of high water.

**A. Probably not with the charitable idea,** as you are talking about using tax dollars for charitable purposes which is not a proper use. But, I think you could assist the adjacent township because it would be for a public purpose.

Make sure, however, to have a special meeting of the township scheduled to approve this expenditure, as no doubt there will be legitimate concerns about use of your budget in this manner. And, I would also advise a written agreement with the adjacent township to outline the reasons and concerns about this one-time appropriation for future reference.

### Q. Are supervisors required to meet monthly now?

**A. No,** monthly meetings of the supervisors are not required, but interestingly, I know of several townships whose supervisors are meeting monthly because it makes it easier to give notice to the county auditor—i.e. "supervisors meet the fourth Wednesday," or "supervisors meet the 5<sup>th</sup> of each month."

They are "finding that by handling business on a more regular basis the meetings are shorter and they can keep better track of monthly bills,


### **NDTOA Director Positions Open for Election**

Interestingly, our public political subdivision counter parts—city councils, school boards, county commissions, park districts, etc., all meet monthly and have been doing so for years. It's probably time for our busier and more active townships to think seriously about getting together more often.

Q. We have an absentee landowner who came to our annual meeting last year and wanted the floor to speak. Did we have to let him do that?

**A. Under Roberts Rules**, there should be a time on the agenda for the public to comment—especially in a public gathering such as a township meeting. The amount of time given for each to comment doesn't have to very long, and should be controlled by the chairman or moderator of the meeting-- e.g. no longer than 5 minutes, etc.

And, remember that the absentee

cannot vote at the meeting because he is not a resident, but it would seem appropriate to allow a township taxpayer such as the absentee to register his thoughts.

Interestingly, this is why notice of annual and special meetings of the township are required to be in the local newspaper, so that interested parties who don't necessarily reside locally can learn of the gatherings.

Q. I notice there is a space on the year-end recap sheet for "meals". When is it appropriate to use township funds for meals?

A. Any time a township officer is on official business and is on duty over a meal hour, then meal expense would be allowed. So, if the officers are at an all-day meeting, then the township should pay for their meals. If a half-day meeting is contemplated, then one meal would be appropriate. I know many supervisors now meet monthly for a couple hours to keep abreast of things, and as long as those get-togethers are officially noticed meetings, then meals are appropriate.

In addition when attending the February workshops (see above) meal expense and mileage should be paid for officers attending. This is all subject, of course, to the budget which the patrons approve at the township annual meeting, and obviously, to monies available.

### **Grassroots Government Leadership Award**

To recognize the leadership, creativity, and dedication of township officials, the NDTOA has established a leadership award to pay tribute every year to an individual whose community service exhibits the highest standard of dedication, ability and service.

#### ELIGIBILITY

The award will be presented to an individual, locally elected official, currently in office. It will recognize him or her for their outstanding contributions on a sustained basis or from a single performance.

Nominees should have responsibility for accomplishing or causing to be accomplished significant programs or projects within their area of responsibility, to the ultimate benefit of the general public.

Examples of such professional accomplishments include local government cost-cutting, coordination of a major local volunteer effort, and promoting townships at the national level, establishing new local services or programs, and success in securing public or private funding for local projects.

#### SELECTING CRITERIA

Nomination should include specific reference to the following features of the nominee's accomplishments as applicable:

- Complexity of the problem(s) addressed.
- Measurable improvements resulting from nominee's accomplishments.

- Use of original, innovative or creative approaches and solutions in difficult situations.
- Long-term or lasting benefit of the nominee's accomplishments.

### **Property Records for Assessment Officials**

Assessment officials now have available three Property Records to consider using for recording each parcel of taxable property in their jurisdiction.

The three property records are for agricultural, commercial, and residential property. To ensure easy access to these records, the Tax Department is hosting the records on our web site at <u>www.nd.gov/tax/</u><u>property/forms</u>.

County, city, and township assessors, the North Dakota Township Officers Association and the Tax Department worked together to identify and develop the minimum requirements for each property record.

The goal was to design a useful tool that assessors could consider using in order to meet the state requirement for recording each parcel of taxable property.

The group also wanted to create a record that could be saved and used in an electronic or paper format. Previously, property records could consist of a few random handwritten notes on piece of paper. That format is no longer acceptable.

The resulting property records are simply a resource to ensure the core elements as set out by the State Supervisor of Assessments are recorded.

The team recognized that some assessment officials might have a robust property record system in place, others might not.

Those assessors with a more developed property record system will likely not need to use these new property records.

However, for those assessors who do not have access to an automated

system, they might want to consider using the new property records.

The property records may be in electronic or paper form and must contain certain information to document data that affects property valuation.

This also helps ensure consistency throughout a jurisdiction, whether the jurisdiction is a township, city, or county. Keep in mind that the County Tax Director must retain the property records for townships and cities in which the population is less than 5,000.

While there is certain information that is standard for each type of record, such as the parcel identification number, property classification and legal description, there are also differences between the records depending upon the type of property.

So, if you decide to use these records, be sure to use the correct record when completing the information.

The records are in a fillable PDF format. You can download and save these records to your computer. And, you can choose to complete the records using your computer or handwrite the information.



# Snow Removal Safety by NDIRF

#### WINTER PREPARATION ALREADY?

The winter season of 2013-2014 is already showing signs of approach. In fact, while writing this in early October, we are in the process today of receiving several inches of the wet white stuff in Bismarck and more in southwest North Dakota – doesn't really seem fair after that late spring we had but, ready or not, here it comes.

Therefore, we need to be ready, rather than not, and be about the business of ensuring safety for winter operations.

Accumulations of snow, whether occurring naturally or as the result of snow removal efforts, can obscure driver sight lines, impede traffic and create access problems – not only for motorists but also for public equipment operators.

Winter snow removal operations create a migrating work zone for which the motoring public often has little regard.

They are a repeated source of accidents and NDIRF notices an up-tick in related claims whenever we experience an above-average snowfall season.

If your township is among those who do your own snow removal there are a number of ways to enhance the safety of these operations, including the following:

Rotating strobe lights increase the visibility of snow removal equipment.

• Back-up alarms reduce the possibility of an incident by providing an audible warning.

• "Warning – Stay Back 50 Feet" signs, mounted on the rear of snow removal equipment, can provide an additional defense against claims.

• Equip all snow removal vehicles with adequate outside mirrors to assist drivers in observing the sides and rear of the unit during operations.

• Check all vehicle and equipment heaters, fans and blowers to ensure they properly remove frost and fog on interior glass.

• Winter survival kits should be assembled and placed in each vehicle and piece of snow removal equipment.

• Consider running public service announcements through local media outlets, reminding citizens of the hazards involved in snow removal operations.

Heavy use and/or an abundance of snow, if that occurs this season, may have you scrambling to find additional snow removal equipment. Often, this equipment lacks some or all of the appropriate safety items. If you haven't already, now is the time to make sure each piece of road working equipment has a strobe or beacon mounted on the top.

Also, rear-mounted SMV and "STAY BACK 50 FEET" signs, visible from a distance of 500 feet, should be installed.

When renting heavy equipment, check that the necessary warning apparatus described above has been installed. Be prepared – and have a **safe** winter.
